## **Hālau Ho'okahi I Ka Hula: Policy Agreement**

*(Please initial by each section to confirm your agreement)*

**Tuition:** Payment is due (\$50/mo per type of class) on the first Saturday of every month. There is a \$10 discount if you enroll in both Makua Hula and Makua Tahitian classes in the same month. Cash, cashier's check or Venmo (preferred) is accepted. Personal checks will no longer be accepted. A \$10 fee will be assessed if payment is not received on the first Saturday of the month. If you will be unable to attend a class for any reason, payment for the full month is still required in advance in order to hold your spot. For each additional student enrolled per month on your account, a \$5 discount will be given. Payments are non-refundable. \_\_\_\_\_ **(initial here)**

**Responsibility:** Please arrive early, with all materials needed. If you're dancing both Hula and Tahitian, please wear your pareo under your pa'u skirt to expedite the transition from class to class. Parents will be responsible for picking up their children after class on time. If you'll be unable to attend, please notify the instructor AT LEAST 24 hours ahead of time. If you miss a class, it is your responsibility to find out what was taught and then catch up. You may do this by either paying for a private lesson or meeting with a halau sister or brother to go over what you've missed. \_\_\_\_\_ **(initial here)**

**Hālau Protocol:** Personal hygiene and grooming are very important in hula. Always take off your shoes before you enter the room. Shoes are not allowed on the dance floor. Cell phones should be silenced. Please do not disrupt the class. Non-dancers (parents, friends, etc) will not be allowed in the dance studio while class is in session. Parents of students are welcome to wait in the lounge and watch the class on the tv screens. If young siblings or other family members or friends are brought to the lounge, we do ask that they sit quietly and watch without disrupting others at the studio. The studio is not a playground; children should be discouraged from running, yelling, or playing inside the studio and/or hallways of the facility. At the end of class, all students should help to close by clearing away trash and sweeping the floor. All classes will end 5 minutes early to aid in cleanup. Please remember to always respect your instructor and instructor's assistants. When you join a class, show respect for your classmates with more experience by remaining at the back of the class. Please be aware that ongoing attendance is necessary to be successful in any class, as choreography is learned in progression. \_\_\_\_\_ **(initial here)**

**Performances:** One of our goals is to display the culture uniformly. In addition to having the same costumes, all dancers must remove all jewelry, remove all nail polish, conceal tattoos, tan if needed, and have hair/makeup done the same way. We all dance "as one". \_\_\_\_\_ **(initial here)**

**No Videography:** You, your family members and/or friends are not allowed to videotape dancers in the halau during the classes. However, you are encouraged to videotape during public performances. It is not appropriate to share what is learned at Ho'okahi I Ka Hula with those outside the halau, including choreography, without permission from the instructor. If you would like to perform a song learned from Ho'okahi I Ka Hula without the rest of the group, you must first perfect the dance as it was intended to be displayed and then perform it in front of the instructor. It will be at the discretion of the instructor to decide whether or not you are ready to use choreography outside of the halau. \_\_\_\_\_ **(initial here)**

## Hālau Ho'okahi I Ka Hula: Waivers and Releases

### **Arizona Dance Studio - Rules, Responsibilities and Waiver:**

4. I understand that I must remove my shoes PRIOR to entering the studio room.
5. I understand that there is no smoking allowed within 20 feet of the building.

I hereby assume responsibility for any damage or loss, caused by myself, my family members and/or friends (including any of my guests that enter with me), to any items or equipment in the studio that belong to Arizona Dance Studio. Any damage caused by anyone in my party, whether intentional or accidental, will result in my responsibility to pay for said damages to the studio within one month.

8. I understand that I must help to keep the facility in good and clean condition prior to my departure.
